

- A teacher shall desist/refrain from including in unscientific publication which would prove to be detrimental to the reputation and the progress of the college/university.
- A teacher may be permitted to take up consultancy under terms and conditions as outlined in the relevant statue/ordinance as amended from time to time. However, he shall not conduct individually or participate in conducting jointly with others coaching


